- 4 Section 6107 of title 38, United States Code, is
- 5 amended to read as follows:

6 "§ 6107. Reissuance of benefits

- 7 "(a) Reissuance of Misused Benefits.—(1) In
- 8 any case in which a fiduciary misuses all or part of an
- 9 individual's benefit paid to such fiduciary, the Secretary
- 10 shall pay to the beneficiary or the beneficiary's successor
- 11 fiduciary an amount equal to the amount of such benefit
- 12 so misused.
- 13 "(2) In any case in which the Secretary reissues a
- 14 benefit payment (in whole or in part) under paragraph (1),
- 15 the Secretary shall make a good faith effort to obtain
- 16 recoupment from the fiduciary to whom the payment was
- 17 originally made.
- 18 "(3) In any case in which the Secretary obtains
- 19 recoupment from a fiduciary who has misused benefits,
- 20 the Secretary shall promptly remit payment of the re-
- 21 couped amounts to the beneficiary or the beneficiary's suc-
- 22 cessor fiduciary, as the case may be, to the extent that
- 23 such amounts have not been paid under paragraph (1).
- 24 "(b) Reissuance of Amounts in the Case of A
- 25 Deceased Beneficiary.—(1) If a beneficiary described
- 26 in subsection (a)(1) predeceases a payment under such

- 1 subsection, the Secretary shall pay such amount, subject
- 2 to paragraph (2), to an individual or entity in accordance
- 3 with section 5121 of this title.
- 4 "(2) The Secretary may not make a payment under
- 5 this subsection to a fiduciary who misused benefits of the
- 6 beneficiary.
- 7 "(c) Limitation on Total Amount Paid.—The
- 8 total of the amounts paid to a beneficiary or the bene-
- 9 ficiary's successor fiduciary under this section may not ex-
- 10 ceed the total benefit amount misused by the fiduciary
- 11 with respect to that beneficiary.
- 12 "(d) Oversight of Negligence.—(1) The Sec-
- 13 retary shall establish methods and timing with respect to
- 14 determining whether an instance of misuse by a fiduciary,
- 15 of all or part of an individual's benefit paid to such fidu-
- 16 ciary, is the result of negligence by the Secretary.
- 17 "(2) The Secretary may not withhold the reissuing
- 18 of a benefit payment under subsection (a)(1) by reason
- 19 of a pending determination under paragraph (1).
- 20 "(3) The Secretary is not required to make a deter-
- 21 mination under paragraph (1) for each instance of misuse
- 22 by a fiduciary, of all or part of an individual's benefit paid
- 23 to such fiduciary.".
